OFFICE MEMORANDUM

Sub:- Filling up the post of Assistant Enforcement Officer in the Directorate of Enforcement in Pay Matrix Level-7 (Rs.44900-142400) on deputation basis-reg.

It is proposed to fill up the posts of Assistant Enforcement Officer in Pay Matrix Level-7 on deputation basis in this Directorate of Enforcement at Delhi, Mumbai, Chennai, Kolkata, Jaipur, Surat, Bhubaneswar, Chandigarh, Lucknow, Jalandhar, Srinagar, Bangalore, Cochin, Hyderabad, Guwahati, Ahmedabad, Panaji, Madurai, Calicut, Raipur, Indore, Nagpur, Dehradun, Jammu, Shimla, Allahabad, Ranchi, Patna, Gurugram, Bhopal, Vishakhapatnam, Mangalore, Gangtok, Agartala, Aizawl, Imphal, Itanagar, Kohima and Shillong.

2. In terms of the Recruitment Rules, the following categories of officers are eligible:-

“Officers from Central Government or State Government or Union territories (Including officers from Central Government or States Government or Union territories Police organizations):

(A)(i) Holding analogous post on regular basis in the parent cadre or department; or

(ii) With five years' service in the grade rendered after appointment thereto on a regular basis in posts in the Level-6 of the pay matrix or equivalent in the parent cadre or department; and

(B) Possessing the following educational qualification and experience:-

(i) A degree in any subject from a recognized university; and

(ii) Two years' experience in the field of Legal Work, Intelligence, Investigation work and Adjudication or prosecution relating to fiscal or criminal laws.

The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

The maximum age limit for appointment by deputation (Including Short term Contract) shall not be exceeding 56 years as on the date of receipt of applications.

3. The Pay & allowances and other terms will be regulated in accordance with the Department of Personnel & Training's O.M. No. 6/8/2009-Estt (Pay-II) dated 17th June, 2010 as amended from time to time. Besides, the officers working in Directorate of Enforcement at level of Assistant Enforcement Officer are currently entitled for Special Incentive Allowance @ 20% of Basic Pay.

4. The Cadre Controlling Authorities are requested that applications of eligible and willing officers may be forward in the proforma annexed so as to reach the Joint Director (Admn.), Directorate of Enforcement, 6th Floor, Lok Nayak Bhawan, Khan Market, New Delhi – 110003. 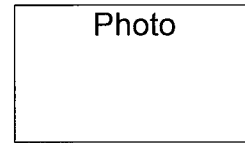
