Sealed Tenders are invited in a 2-Bid system for renting of photocopy machines of branded Company on Comprehensive Basis (machines to be supplied, installed and fully maintained by the service provider, including the Toners, ink, spares, consumables etal) alongwith photocopy papers and photocopy operator. The bidders are to quote their best rates for a period of two years starting from 1st May, 2018, subject to satisfactory performance (extendable for a further period of one year) in the office of the Joint Director, Directorate of Enforcement, Bengaluru Zonal Office, 3rd Floor, B Block, BMTC Shantinagar TTMC. The Technical bids will be evaluated by Technical Bid Committee. Commercial Bids of only those Bidders will be considered whose Technical Bids qualify as per the eligibility criteria. The eligibility criteria are based on fulfilment of the description of items as given above.

The Bids should reach the undersigned by 13th April, 2018 either by post or through an authorised representative. The technical and Commercial Bids would be opened on 16th April, 2018 at about 11.00 Hours in the conference room of the office at the address aforemetioned.

Those desirous to be present at the time of opening of tenders should carry proper authority letter. Submission of Bids by itself does not confer any right or entitlement to do the job. Unsealed Bids will be rejected outrightly. The Competent authority reserves the right to accept or reject any or all tenders received, without assigning any reasons what-so-ever. Terms and conditions on which the work will be awarded to the successful tender are appended below. Terms and conditions:-

- 1) All Photocopy machines to be supplied and installed should be of a branded Company and in good working conditions.
- 2) The installation charges, transportation charges and other incidental charges should be inclusive of the total cost.
- 3) No deposit will be paid.
- 4) Toners, spares, consumables, services and photocopy paper will be provided free of cost by the contractor.
- 5) Payment will be made only on the total number of copies printed on monthly basis.
- 6) Payment against Bill/Invoice shall be released only after supply/installation and observance of satisfactory performance of the photo copiers.
- 7) 1% wastage reduction on total number of copies on monthly billing.
- 8) Breakdown calls to be attended immediately/within the same day.
- 9) Bids must be accompanied with photocopy of PAN card.
- 10) The requirement of quantity of photocopiers is subject to variation at the discretion of this office without assigning any reason.
- 11) Tender for items of lower configuration vis-a-vis specified at Sr, no, 1 will be summarily rejected. Erasing and overwriting in the rates quoted will make the tender void. All alterations in the rates should be signed in ink otherwise the tender will not consider.
