- 2. Accordingly, sealed quotations are invited for the sale of the said above said vehicles on the term & conditions mentioned below. Person/firms interested to purchase the above mentioned staff car/vehicles, may submit their quotations in the enclosed proforma in a sealed cover addressed to undersigned latest by 3.00 P.M. on 22<sup>th</sup> Nov, 2018. The quotations received in time will be opened at 04:00 P.M. on or before 26<sup>th</sup> Nov, 2018. The cover should be prominently mentioned with the words "QUOTATION FOR PURCHASE OF CONDEMNED VEHICLES". The vehicles will be available for inspection between 03:00 PM. To 04:00 PM on 15<sup>th</sup> & 16<sup>th</sup> Nov, 2018.
- The quotations received in time will be opened by the bid evaluation Committee in the room of Deputy Director (Admin)of this office. The bidders or their representative (not more than for each quotations) may be present, if they so desire, at the time of opening of Quotations.
- The sale will be governed by the following conditions:-
  - (a) The bidders are required to pay Earnest Money Deposit (EMD) OF Rs. 5,000/-(Rupees Five Thousand Only) for the vehicle payable by means of Demand Draft/Cheque from any of the commercial bank, drawn in favour of PAO Departmental of Revenue, Ministry of Finance, New.
  - (b) Quotations received without Earnest Money Deposit (EMD) will not be considered and will be rejected.
  - (c) The successful bidder will be required to deposit the bid amount by means of Demand Draft/Banker's Cheque from commercial bank drawn in favour of PAO, Departmental of Revenue, Ministry of Finance, New Delhi within seven working days of the acceptance of the bid.
  - (d) The EMD of the successful bidder will be released only after the deposit of the sale proceeds and will be forfeited, if he fails to honour the bid.

- (e) The delivery of the sold vehicle will be arranged only after the successful bidder submitted documentary evidence in support of residential status viz. Aadhar Card/. Voter Identity Card / Ration Card/ Passport in case of individual and Registration Certificate, in case of first time etc.
- (f) The sold vehicle has to be removed by the successful bidder within five days of depositing the bidding amount at his own expenses.
- (g) The vehicle will be disposed off on "as is where is basis" and no guarantee for its worthiness or quality will be given by the department.
- (h) The successful bidder will also be responsible for getting the Registration Certificate of the Vehicles transferred in his name at his own cost expeditiously.
- The bidders will not be allowed to withdraw their bids and if they do so their earnest Money Deposit (EMD) will be forfeited.
- (j) The Competent Authority in Directorate of Enforcement reserve the right to accept or reject any/all of the quotations without assigning any reason.
- (k) Proforma for offering rate for disposal of Condemned vehicle is available at Annexure –I.
- Bids will be assessed and highest bidder in respect of vehicle will be the successful bidder.
- (m) Employees of this Department and Ministry are not eligible to participated in this bid.
