TERMS AND CONDITIONS OF TENDER NOTICE No. 02/2019-2020

- The service provider shall be required to provide a self attested copy of registration documents/The vehicle provided under the contract must be properly and comprehensively insured and should carry necessary permits/clearance including pollution clearance certificate from, the concerned state transport authority or any other concerned authority.
- 2. The rates for hiring of car shall be:-

- 3. Contract charges include charges of driver, repair and, maintenance of vehicle, petrol or diesel and also other expenses.
- 4. The vehicle shall be provided for the exclusive use of the office and shall not be used by the contracted agency for any other purpose.
- 5. In case of any accident, all claims will be met by the contractor.
- 6. If the vehicle gets out of order the contractor shall provide substitute vehicle immediately. In case vehicle does not report on time or does not report at all, the Directorate would have the right to hire a vehicle from market and the additional cost incurred by directorate would be borne by the contractor.
- 7. The service provide shall maintain a record of journey performed by the hired vehicle in a log book system which shall be verified by an officer in charge of hired vehicle in the Directorate of Enforcement, Dehradun. Only the mileage verified by the in charge officer will be taken into consideration by this office at the time of payment of bill.
- 8. Payment shall be made at the end of the every month on the basis of actual bill.
- 9. The service provider shall ensure compliance of all labour laws.
- 10. The driver of the vehicle must follow all traffic rules and other regulations prescribed by the govt. Of India time to time.
- 11. The service provider must provide the name & address of the driver with an attested copy of the driving licence of the driver clearly indication the driver's name and period of validation. Once the hiring commences the driver deployed with the vehicle will be changed/retained only on the recommendation of this officer.

- 12. The service provider must submit an undertaking that neither he nor his firm has been blacklisted by any state or central govt. Organisation.
- 13. The contract between the Directorate and contractor can be cancelled with prior notice of 30 days from either side.
- 14. In the event of any unsatisfactory performance of the vehicle or driver, the contract can be cancelled without assigning any reason whatsoever.
- 15. Dedicated driver and vehicle must be provided. The vehicle can be availed at any time of the requirement of the directorate.
- 16. The driver must observe all the etiquettes and protocols while performing his duty. He must be neatly dressed should wear proper uniform and remain disciplined during the course of duties.
- 17. The driver must carry a mobile phone which should be available for 24 hours,
- 18. The operator and driver shall be bound to carry out the instruction of the directorate and its officers to whomsoever vehicle in assigned.
- 19. The contract will be effective from 23.10.2019 to 22.10.2020 unless terminated earlier as per the clause provided in the agreement.
- 20. The contract can be extended for a period up to three years on yearly basis & on mutual understanding and granting satisfactory services.
- 21. Penalty Rs. 2000/- will be levied if the vehicle fails to meet the above mentioned terms and conditions.
- 22. All damages/charges arising on account of or connected with the negligence of the service provider/contractor agency or its staff or any person under his control whether concerning public or any person in general while executing the contracted work or otherwise will be settled by the contractor.
